

TOWN OF VIEW ROYAL NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN pursuant to the *Local Government Act* that a Public Hearing will be held at **the Town of View Royal at 45 View Royal Ave, Victoria BC at 7pm on Tuesday, June 19, 2018** for the purpose of hearing representations concerning the following proposed amendments:

Zoning Bylaw No. 900, 2014, Amendment Bylaw No. 1000, 2018 proposes to amend Zoning Bylaw No. 900, 2014 regarding the P-4: Regional Institutional zone (at 94 Talcott Rd as shown on the plan on the reverse of this notice) as follows:

- 1. Section 2.2 DEFINITION will be amended to add definitions of "Commercial Kitchen", "Craft and Artisan Trades", "Market Garden" and "Therapeutic Recovery Community".
- 2. Section 11.4.1 P-4: Regional Institutional will be amended to add "Therapeutic Recovery Community" to the permitted Principal Uses within the zone.
- 3. Section 11.4.1 P-4: Regional Institutional will be amended to add "Commercial Kitchen", "Craft and Artisan Trades", "Market Garden" and "Service Store" to the permitted Accessory Uses within the zone.
- 4. Section 4.4.1 will be amended to permit no more than 50 chickens on a lot, which are to be kept in hen houses. No roosters, egg sales, meat sales, or slaughter of chickens will be permitted.
- 5. Section 3.8.2 will be amended to prohibit the keeping of chickens and bees within special setback areas (15m from the natural boundary of the sea, or 30m from the natural boundary of any lake, pond, marsh or stream, subject to the Provincial Riparian Area Regulations).
- 6. Section 4.4.2 will be amended to permit the keeping of bees (up to 8 beehives) within the P-4 zone.
- 7. Table 5.2 Off Street Parking Schedule Public and Institutional will be amended to include parking requirements for the uses of Therapeutic Recovery Community, Therapeutic Recovery Community Office, and Correctional Facility.
