

TOWN OF VIEW ROYAL NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN pursuant to the *Local Government Act* that a Public Hearing will be held at **Town of View Royal Town Hall, 45 View Royal Avenue, Victoria, B.C. at 7:00 pm on Tuesday, January 21, 2020** for the purpose of hearing representations concerning the following proposed amendments:

Zoning Bylaw No. 900, 2014 Amendment Bylaw No. 1034, 2019 proposes to change a permitted use within I-1: Light Industrial zone from 'Medical Marijuana Production Facility' to 'Cannabis Production Facility' for lands addressed as 1 Adams PI (Adams Storage) and legally described as:

THAT PART OF SECTION 95, ESQUIMALT DISTRICT, LYING NORTH OF THE RIGHT OF WAY OF THE ESQUIMALT AND NANAIMO RAILWAY COMPANY AS SAID RIGHT OF WAY IS SHOWN COLOURED RED ON PLAN DEPOSITED UNDER DD 2797

TAKE NOTICE that <u>no cannabis-related use is proposed for the site</u>. This is a text amendment to the existing permitted use within the Light Industrial zone as part of a proposal to bring the language and land uses into consistency with provincial and federal cannabis legislation. There are other cannabis-related amendments to Zoning Bylaw No. 900, 2014 proposed by this bylaw and addressed by this Public Hearing which affect the entire Town. 
