NOTICE IS HEREBY GIVEN that the following application is being considered:

Application Description:	<ul> <li>This application addresses the following variance within <i>Zoning Bylaw No. 900, 2014</i>:</li> <li>Variance to the length of a parking space within Section 5.5.1 from 5.5m to 5.3m.</li> <li>If approved, the variance would permit one existing driveway parking space to count towards the formal parking requirements of two spaces per dwelling and allow one vehicle space in the two-car garage to be converted into a study. Note: small car parking spaces are typically 4.8m long and there are no proposed building exterior changes</li> </ul>

The application will be considered by the View Royal Town Council on **Tuesday**, **May 3**, **2022 at 7:00 pm** and may by resolution:

- (a) authorize the issuance of the Development Variance Permit.
- (b) authorize the issuance of the Development Variance Permit as amended by Council in its resolution.
- (c) defer consideration of the Development Variance Permit to a future date, or
- (d) refuse to authorize a Development Variance Permit for the current proposal.

Application information will be available for review prior to the meeting on the Town's website at <u>www.viewroyal.ca</u> under Quicklinks → Agenda's Minutes & Videos. The agenda is posted on the Friday before the meeting. There will be an opportunity for public comment on the application at this meeting. View Royal Council Chambers is open for the public to attend meetings in-person. Although not required, wearing a mask is recommended when attending meetings.

Alternatively, should you wish to participate electronically, this meeting will be live webcast and during the live webcast there will be an opportunity for public comment on the application.
