Application Description:	This is a Town initiated application to apply zoning to an area currently under a Land Use Contract. The Bylaw creates a new zone called CD-27: Comprehensive Development (Glentana Village) and applies it to the lands affected by a Land Use Contract.  The CD-27 Zone (Glentana Village) is drafted to recognize the existing uses and density on the site, and includes provisions for use, density, lot size, setbacks, building height, lot coverage, impermeable surface coverage and parking. Land Use Contracts are being phased out of the Local Government Act.
