	Requested variances to Zoning Bylaw No. 900, 2014 include:  • Locate an accessory structure in the front yard (Section 4.6.2 c)  • Reduce the total number of required loading spaces from 5 to 2 spaces (Section 5.10)  • Reduce the total required number of parking spaces from 283 spaces to 247 (Section 5.10).  (cash in-lieu for 42 additional stalls will be made as per Section 5.9)  Requested variances to Sign Bylaw No. 950, 2022 include:  • Locate signs below the minimum vertical distance from grade from 2.4m to 1.34m (Section 6.7)  • Increase the total number of logo signs from 1 to 2 (Section 6.3)  • Increase the maximum area of logo signs on a single wall face from 2m² to 7.4m² (Section 6.7)  • Increase the maximum character size from 45cm to 137cm (Section 7.2 b)
