



# TOWN OF VIEW ROYAL NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN pursuant to the *Local Government Act* and *Provincial Ministerial Order M192 dated June 17, 2020* that an electronic Public Hearing will be held on Tuesday, July 7, 2020 beginning at 7:00 p.m., for the purpose of hearing representations concerning the following proposed zoning amendments on the property addressed as **107 Cheltenham Street** and legally described as follows:

LOT 17, BLOCK 3, SECTION 9, ESQUIMALT DISTRICT, PLAN 1291, EXCEPT THE RIGHT OF WAY OF THE CANADIAN NORTHERN PACIFIC RAILWAY COMPANY AS SHOWN ON PLAN 8RW

*Zoning Bylaw No. 900, 2014, Amendment Bylaw No. 1053, 2020* proposes to rezone the subject property from *R-1B: Detached Residential (Medium Lot)* to *R-1C: Detached Residential (Small Lot)*. If the bylaw is approved, the Floor Space Ratio would be increased, allowing the property owner to enclose the existing carport to increase living space.

The Public Hearing will be held via teleconference due to the ongoing COVID-19 public safety measures and enabled by *Provincial Ministerial Order M192*. If you are unable to participate in the Public Hearing, written comments may be mailed, facsimiled, emailed or hand delivered to the Town of View Royal by no later than 3:00 pm on July 7, 2020.

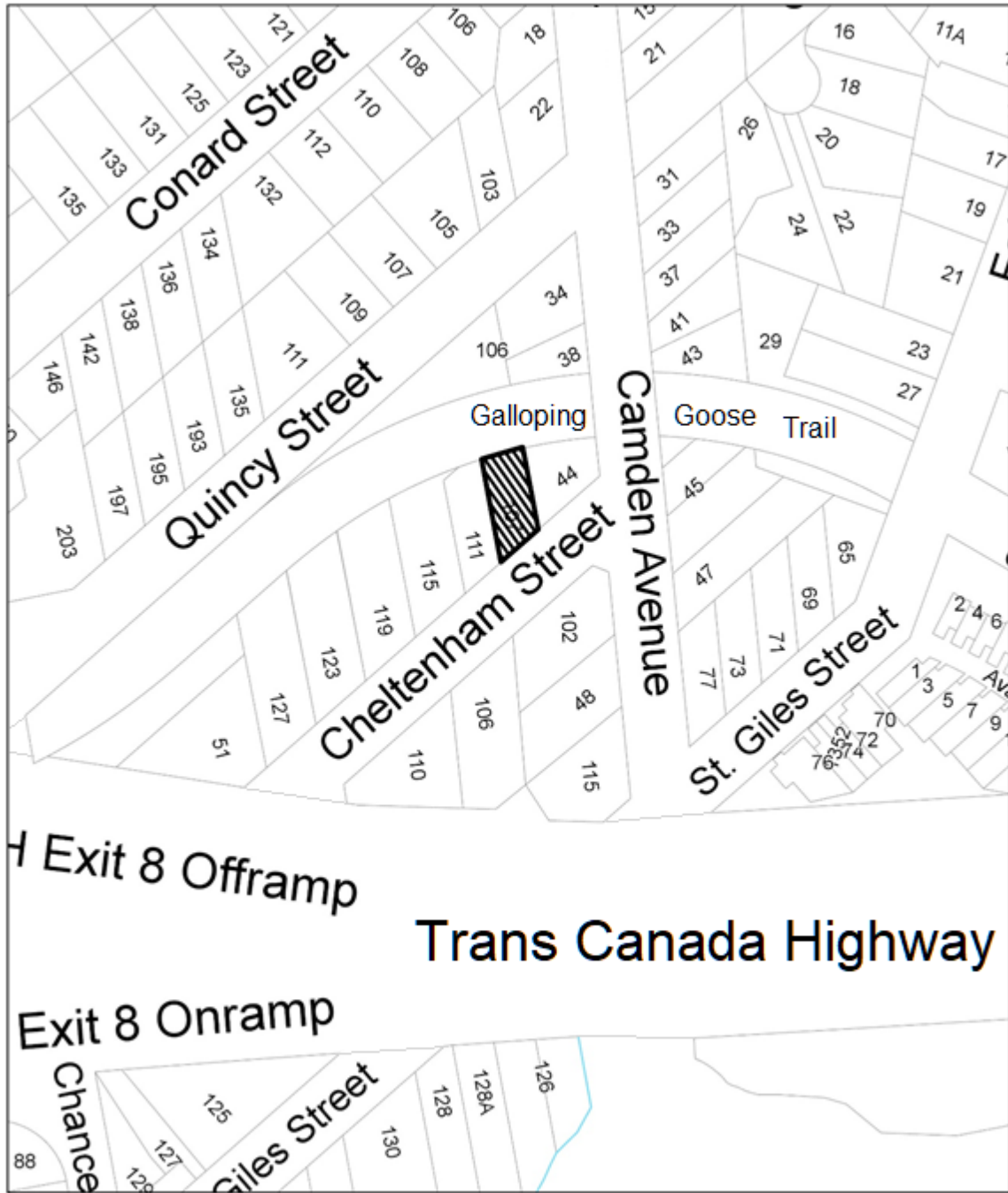
