



## TOWN OF VIEW ROYAL NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN pursuant to Sections 890 and 892 of the *Local Government Act* that a Public Hearing will be held at **Town of View Royal Town Hall, 45 View Royal Avenue, Victoria, B.C. at 7:00 pm on Tuesday, July 7, 2015** for the purpose of hearing representations concerning the following proposed amendment:

**Bylaw No. 928, 2015 proposes to amend Zoning Bylaw No. 900, 2014 as follows:**

1. Subsection 11.9 of Bylaw No. 900 is hereby amended by adding the "**CD-9D: Lakeside Village Mixed Commercial**" Sub-Zone Table into the CD-9 zone, immediately after the "CD-9CS: Lakeside Village Low Density Suite Residential" Sub-Zone Table. The CD-9D Sub-Zone is identical to the CD-9A: Lakeside Village Mixed Tourist / Retail Commercial and Residential Sub-Zone with the exception of the addition of "**Restaurant, Full-Service**" to the list of Principal Uses in the CD-9D Sub-Zone.
2. Schedule "B" Zoning Map referred to in Section 1.7 of Zoning Bylaw No. 900, 2014 is amended by amending the zoning and zoning boundaries for lands addressed as **430 Six Mile Road** and legally described as **LOT A SECTION 6 ESQUIMALT DISTRICT PLAN VIP87819** as shown outlined on the attached sketch plan, from CD-9A: Lakeside Village Mixed tourist / Retail Commercial and Residential to **CD-9D: Lakeside Village Mixed Commercial**.

The applicant requests rezoning to facilitate a full-service restaurant use on the property.

**TAKE NOTICE** that detailed information concerning the subject bylaw and any other reports and documents that may be considered by Council can be obtained at the Town of View Royal Municipal Office, Development Services Department, 45 View Royal Avenue, Victoria, B.C. Note that the Town Hall is closed on Wednesday July 1, 2015.

All persons who believe that their interest in property is affected by the proposed Bylaw shall be afforded an opportunity to be heard in person, by a representative or by written submission on all matters contained therein at the above-noted time and place. If you are unable to attend the Hearing, written comments may be mailed, facsimiled, emailed or hand delivered to the Town of View Royal by no later than 4pm on July 7, 2015.
