9. NEW BUSINESS

a) Clarification of "In Stream Projects" for Proposed Building Bylaw No. 1111, 2023 – L. Jeaurond

Information from the Director of Development Services:

- Any building permit application for a Part 9 residential building received on or after November 1, 2023 must comply with Zero Carbon Step Code Level 4.
- Any building permit application for a Part 3 building with major occupancy classified as residential that is less than six stories that is received on or after July 1, 2024 must comply with Zero Carbon Step Code Level 4.
- Any building permit application for a Part 3 building with major occupancy classified as residential occupancy, business and personal services occupancy, or mercantile occupancy that is received on or after November 1, 2024 must comply with Zero Carbon Step Code Level 4.

b) Prohibiting Renewable Natural Gas – I. Brown

Information from the Director of Development Services:

The proposed new building bylaw (Building Bylaw No. 1111, 2023), which Council will consider for fourth reading and final adoption on October 3, refers to the Zero Carbon Step Code requirements in the BC Building Code. To meet Level 4 Zero Carbon Performance, space and water heating, and cooking ranges must be, in most cases, full electrification. Prohibiting renewable natural gas (RNG) as a heating and cooking source in buildings would be a separate bylaw for Council consideration if they would like to enforce this in the Town. This restriction would go beyond the Zero Carbon Step Code requirements in the BC Building Code.

c) Strengthening Tree Protection Bylaw in New Developments – I. Brown

Information from the Director of Engineering

- An Urban Forestry Strategy (N-074) project terms of reference is being prepared and will be provided elected officials prior to release of the request for proposals.
- On the Action List already is a staff report to explore options to further strengthen Tree Protection Bylaw No. 1069, 2022 (C-63-23) from April 2023.
- Currently, staff are asking many more questions of developers' arborists regarding additional protection measures as early as the rezoning stage of development proposals. Staff have recommended that applicants provide a tree preservation plan which incorporates additional measures such as irrigation, mulching, reduced blasting, and different foundation excavation methods (short term tool). These are currently beyond the requirements of the Tree Protection Bylaw.
- The bulk of changes to the Tree Protection Bylaw (long term tool) will be predicated on the establishment of this Urban Forest Strategy (medium term tool) and PREAC is anticipated to be involved in the Strategy.
